◆ Exhibitor registration forms received without payment or permits will not be processed.

◆ Exhibitor set-up Thursday, Nov. 4, 2010 from 1:30 PM to 5:30 PM and Friday, Nov. 5, 2010 from 7:30 AM to 9:00 AM. All exhibitors are required to register before entering the exhibit hall for set-up and to pick up their exhibitor ID.

◆ All exhibitors must dismantle their booths at 6:00 PM on Saturday, Nov. 6, 2010.

◆ **For 8' Table** (no pipes and drapes), (one) 8' table, (two) chairs and (two) exhibitor passes will be provided.

For 10' x 10' booth, (one) 8' table, (two) chairs and (four) exhibitor passes will be provided.

For 10' x 20' booth, (two) 8' tables, (four) chairs and (eight) exhibitor passes will be provided. Additional 8' table costs \$50.

◆ Loading / Unloading (Dock) parking limited to 1 hour, located in back of Exhibit Hall A. Parking lot B, C costs \$ 8.00 per day (one-time entrance only).
